It is proposed to conduct selection for forming a panel for one post of AFA (Group-B) in Pay Matrix Level-9 i.e Pay Band-2 of Pay Rs. 9300-34800 + GP of Rs. 5400/- against 30% quota reserved for UR candidate. The break-up of vacancy for which selection is proposed to be held as under.

The eligibility condition for appearing in the examination are as under:

- 1) The candidate should have passed the Appendix III A IREM Examination
- 2) The candidate working in Level-6 with Grade Pay Rs.4200/- and above in Pay Matrix with 5 years of non fortuitous service in Level-6 and above in Pay Matrix (including non-fortuitous service rendered in the corresponding pre-revised grade pay) shall be eligible

The selection shall consist of Centralized Computer Based Objective Type Examination conducted by DG/NAIR followed by viva-voce to those who qualify in the CBT examination. CBT Examination will be conducted on 14.05.2023(tentative)

It is the responsibility of the candidates to advise their willingness or unwillingness to appear in the selection in the format given in Annexure-I, so as to reach this office on or before 14.03.2023 positively. Any failure to respond or furnish the intimation by the candidates within the date stipulated will be treated as unwillingness on their part to appear for the selection.

The final list of eligible candidates to appear in the above selection will be notified on 19.03.2023 and no alteration will be made in the field of candidates and only the candidates appearing in the final list will be allowed to appear in the written test/selection.

Railway Board has introduced Centralized Computer Based Objective Type examination in all Department having Organized Services. The LDCE selection will be one stage only and will comprise of one paper with the following setup:-

- II) Qualifying Marks for above Exam is 90 Marks
- III) Duration of Exam is 3 Hours.
- IV) Question paper will have 175 questions out of which 150 questions are to be attempted.
- V) 1 mark will be allotted for every correct answer. There shall be negative marking for incorrect answers and 1/3<sup>rd</sup> of Marks allotted for each question will be deducted for every wrong answer.

After the viva-voce test, for empanelment purpose, the name/s of qualified candidate/s will be arranged in the order of merit on the basis of aggregate marks obtained by them.

CBT for 30 % LDCE for Accounts Department for Zone/PUs will be held on the same day across Indian Railways. Hence no supplementary examination is entertained under any circumstances.

The eligible candidate(s), who satisfy the above-mentioned conditions, may submit their option in proforma enclosed i.e., as per **Annexure-I** herewith on or before **14/03/2023**.
