SCHEME OF EXAM

The above selection will consist of a written test followed by medical test and viva-voce to those who qualify in the written test. The written test will consist of the following subjects:

* One optional question to the extent of 10% of the marks on Official Language Policy and Official Language Rules will be included. The syllabus for the above examination is General & Practical in nature in order to judge the suitability of the candidates in various fields of Railway working in the Accounts Department. The candidates are allowed to bring the Railway code books and manuals for the written examination. The above scheme of examination is based on Railway Board Letter Nos. E(NG)1/2008/PM/1/4 Dated 14.12.2018, E(GP)2018/2/31 Dated 19.03.2019 and E(NG)I/2018/PMI/4 Dated 30.06.2022
