

Railway Board vide their letter dated 30.09.2016 have advised that RBE No.126/2010 dated 01.09.2010, is held in abeyance with immediate effect until further advice and all further promotions of reserved category persons to unreserved posts will now be made by ignoring Railway Board's RBE No.126/2010 dated 01.09.2010. In view of the above instructions of the Railway Board, the empanelment of the above candidates will be subject to outcome of the main SLPs and the contempt petition which are still pending.

The panel has been approved by the competent authority viz., PCEE on 18.07.2022 and will be valid for a period of two years or till exhausted, whichever is earlier.

The above panel is subject to outcome of OAs/Writ petitions/SLP, in the CAT, High Courts, Supreme Court as the case may be, if any.


