The above selection will consist of a Centralized Computer Based Test of one paper 100% objective type multiple Choice Questions conducted by DG/NAIR, Vadodara followed by viva-voce to those who qualify in the written examination. The date, time and venue of the written examination will be intimated in due course.

### FIELD OF ELIGIBILITY:

In terms of latest Railway Board's letter No. E(GP)2024/2/28 dated 08.10.2024, in respect of 70% Selection to Group 'B' post, all employees who are eligible and who volunteer for the selection should be considered without any limitation of number.

It is also stated that there is no negative marking in the written examinations held as part of Selections (70%) where the final panels are made on Seniority basis.

The final list of eligible candidates to appear in the above selection will be notified on 10.12.2024 and no alteration will be made in the field of candidates and only the candidates appearing in the final list will be allowed to appear in the written test/selection.
