

OFFICE ORDER No. RWF/ESTT/219 DATED 02.09.2022

Shri. Jinna Abhilash (SC), (Staff No.32192), Depot Material Superintendent, working in Stores Department in Level – 6 of RS(RP) Rules, 2016 who has been empanelled to the Ex-Cadre post of Shipping Inspector in Level – 7 of RS(RP) Rules, 2016 vide this Office memorandum No.RWF/NG-40/862 dated 31.01.2022, is promoted and posted as such, against the said Ex-cadre post to be operated in RWF, as communicated vide this Office Memorandum No.RWF/NG-40/862 dated 30.08.2022, consequent on repatriation of Shri H T Lakshmikantha (030816), who was working as Shipping Inspector (Ex-Cadre) in the cadre as Ch.OS/Stores in Level – 7, subject to the following terms and conditions.

- The posting is purely against an ex-Cadre post in Stores Department governed by the existing terms and conditions applicable for the same.
- The posting in the ex-cadre post is normally for a period of four years, which can be extended upto one year beyond the normal tenure of four years i.e., for a total period of five years, with specific approval of competent authority.
- His lien will be continued to be maintained in his parent cadre for the purpose of seniority, confirmation etc., during his tenure/posting in the above ex-cadre post in the Stores Department.
- He is liable to be repatriated back to his parent cadre at the discretion of administration for administration reasons even before completion of his normal tenure of four years in the above ex-cadre post, without assigning any reasons whatsoever.
- His continuance in the ex-cadre is subject to extension of tenure of the above Temporary post of Shipping Inspector on yearly basis, the currency of which is presently upto 30.06.2023 communicated vide this Office Memorandum No.RWF/NG-40/862 dated 30.08.2022.


