रेलवे बोर्ड के पत्र संख्या PC-VII/2016/R/1/1/2 PV-VII No. 170 दिनांक 21.06.2021 (RBE 39/2021) के अनुसार, ग्रेड वेतन 4800/- (पीबी-2)/लेवल-08 में वरि.सेक्शन अधिकारी/वरि.आईएसए के पद पर 04 साल की नियमित सेवा पूरी करने के फलस्वरूप, लेखा विभाग के निम्नलिखित कर्मचारियों (वरिष्ठ से.अ./वरि. आईएसए) को नीचे दी गई तिथि से एतद्वारा 7वें सीपीसी के ग्रेड वेतन 5400/- (पीबी-2)/लेवल-9 में गैर-कार्यात्मक उच्च ग्रेड वेतन में रखा जाता है।

Consequent upon completion of 04 years regular service in the post of Sr.SO/Sr.ISA in Grade Pay of 4800/- (PB-2) /Level-08, the following employees (Sr.SOs/Sr.ISAs) of Accounts Department are hereby placed in the Non-functional higher Grade Pay of 5400/- (PB-2)/Level-9 of 7th CPC w.e.f. the date mentioned below in terms of Railway Board's letter no. PC-VII/2016/R/1/1/2 PV-VII No. 170 dtd 21.06.2021 (RBE 39/2021)

1. The upgradation shall take effect from the date mentioned against the name of each employee.

2. The above employees are eligible to exercise option within a period of one month for fixation of pay. If no option is exercised within a period of one month from the date of issue of this order, the pay shall be fixed under Rule 1313 (FR-22) and as per guidelines time to time issued by Board in this regard.
3. Those employees who got the benefit in Level-9 under MACPs after due date of Non-functional upgradation, the pay may be fixed from the due date of NF as per para 2 above.
4. The designation, duties and responsibilities, seniority and classification in Group 'C' of employees will remain unchanged after granting of up gradation in GP-5400/- Level-9 on non-functional basis.
5. After grant of this upgradation and pay fixation, there will be no further pay fixation in case of subsequent promotion of the supervisor to the post of Accounts officer in Level-9.
6. This upgradation will be reckoned as a financial upgradation for the purpose of MACP.
7. This upgradation will supersede the upgradation under MACP to Level-9 already granted after 01.01.2016, wherever applicable.
8. This order is provisional subject to any clarification/instructions being received from Railway Board regarding modalities or terms & conditions for implementation of upgradation in GP-5400/- Level - 9 on non-functional basis and accordingly excess amount will be recovered.
