In view of the above instructions of Railway Board, the above promotions will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP (C) No.4831/2012 which are still pending.
- 3) That they are free from DAR/SPE/Vig. cases and not undergoing any penalty debarring them from promotion.
