NOTIFICATION

Sub: Re-engagement of retired Non-gazetted staff against vacant posts on contractual basis- Filling up of one post of Senior Progress Inspector in Level-7 in Railway Board's Office, New Delhi, in exigencies of services.

Ref: Railway Board's letter Nos. E(NG)II/2024/RC-4/9 Dated 15.10.2024 (RBE No. 96/2024) and 31.12.2024 (RBE No. 115/2024).

Closing Date and Time for receipt of applications: 17.00 Hrs of 31.01.2025 (Friday)

It is proposed to fill up one non-gazetted post of **Senior Progress Inspector in Level-7 in Railway Board's Office, New Delhi, by re-engagement of retired staff in Level-7 (Technical or Non-Technical) on contractual basis**, in exigencies of services, as per the above instructions of Railway Board, under the control of Stores department/RWF, subject to the following terms and conditions:-

1.0	ELIGIBILITY CRITERIA	
1.1	Age limit	Upto 65 years of age
1.2	Validity of the scheme	The scheme will remain in vogue for an initial period of 2 years from the date of issue of the above instructions of Railway Board or till further orders, whichever is earlier. Engagement period of an individual retired Non-gazetted staff will be for a period of 01 (one) or till further orders, whichever is earlier. However, based on the satisfactory performance of a re-engaged retired staff, his/her period of engagement can further be extended for a further period of one year or till attainment of 65 years of age, whichever is earlier.
1.3	Retired Non-gazetted staff (Technical or Non-Technical), who are proposed to be re-engaged against this Notification, should have held the same pay-level 7 in non-fortuitous/substantive grade at the time of his/her retirement for applying for the above post. On his/her re-engagement, he/she will be designated as Senior Progress Inspector in Level-7 and will be posted in Railway Board's Office, New Delhi. However, such retired non-gazetted staff (Technical or Non-technical) who were granted Financial Upgradation in Level-8/Level-9 under the Modified Assured Career Progression Scheme (MACPS)/who were granted Financial Upgradation to Level-8 (Non-gazetted) due to upgradation of certain Group 'C' cadres as per Railway Board's letter No. PC-VII/2019/RSRP/3(Pt.1) RBE N(o. 155/2022), are also eligible to volunteer.	
1.4	Retired Non-gazetted staff being re-engaged should not have been covered under the Safety Related Retirement Scheme/ Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).

1.5	Re-engagement of retired staff for the above post will be decided on merits of the requirement and suitability of the candidate for the job. In this regard, work experience of the retired staff in the relevant field will also be considered, at the time of their re-engagement for the above post, to ensure that they are useful for which they are being selected.
1.6	Re-engagement of retired staff for the above post will be subject to their possessing high Integrity. In case of any doubtful Integrity, they will not be considered for re-engagement.
1.7	Re-engagement of retired staff for the above post will be subject to the candidate being medically fit in the appropriate medical category, for which they will have to undergo the prescribed medical examination, as per the existing practice.
1.8	The employees who were Removed/Dismissed/Compulsorily Retired as a result of Disciplinary action or under Age Review are NOT ELIGIBLE for re-engagement.
1.9	For the purpose of re-engagement last five (5) APARs of the retired employees seeking re-engagement will be taken into consideration and only those having atleast 'Good' grading in all the five (5) years shall be considered. Suitability/Competency of the applicant will be adjudged by a committee of Officers before their re-engagement duly taking into account safety and other operational requirement.
1.10	The retired employees proposed to be re-engaged should be free from DAR/VIG cases before their re-engagement.
1.11	Re-engagement of retired non-gazetted staff shall not be considered as a case of re-employment.
2.0	REMUNERATION/ALLOWANCES
2.1	A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract.
2.2	No increment, Dearness Allowance and HRA shall be allowed during the term of the contract.
2.3	An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the re-engaged retired staff at the time of his/her retirement. The amount so fixed shall remain unchanged during the term of engagement. However, TA/DA will be allowed on official tour, if any, as per their entitlement at the time of retirement.
3.0	LEAVE ENTITLEMENT
3.1	Paid leave of absence is allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year is not allowed.
4.0	Re-engage staff shall not be made incharge of the unit. Further, re-engaged staff cannot exercise the financial and D&AR powers and they shall not be authorized to issue any safety certificate. However, they may recommend their suggestions on financial and other matters to regular or in-service staff/Officer. They will not divulge any information gathered by them during the period of re-engagement related to the organization to anyone who is not authorized to know/had the same.

5.0	Retired Non-gazetted staff shall execute an agreement to abide by all the terms and conditions of re-engagement.
6.0	The duty hours of the retired re-engaged staff would be as prescribed by this administration from time to time.
7.0	The administration reserves the right to terminate the services of the retired re-engaged Railway Employees for the above post of Senior Progress Inspector in Level-7 in Railway Board's Office, New Delhi, at any time, in case their work or conduct is found to be un-satisfactory or even in administrative exigencies. Their services will also be discharged/ terminated immediately on joining/ positioning of selected candidates from RRB panels, etc. The decision of RWF Administration in this regard, shall be final.
8.0	How to apply
8.1	Applications should be submitted only in the prescribed format as per Annexure. It shall be filled in A-4 size paper.
8.2	The application format is also available for download in the RWF website @ www.rwf.indianrailways.gov.in
8.3	One passport size photograph should be pasted on the application form at the space provided.
8.4	Self-attested photocopies of the following documents should be enclosed:-
(i)	Service Certificate
(ii)	Pensioner Identity Card
(iii)	Pension Payment Order (PPO)
8.5	The applicants should bring all the original certificates when they are called to appear for assessment of their suitability/competency for their re-engagement for the above post.
