

Railway Board vide their letter No.2016-E(SCT)/I/25/8 dated 30.09/2016 (RBE No.117/2016) have advised that instructions contained in RBE No.126/2010 dtd. 01.09.2010, should be held in abeyance with immediate effect until further advice, and all further promotions of reserved category persons to unreserved posts will now be made by ignoring Railway Board's RBE No. 1376/2010 dt. 01.09.2010. In view of the above instructions of Railway Board, the Railway Board

promotion/s will be subject tooutcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP(C)No.4831/2012 which are still pending. Railway Board vide their letter dated 11.11.2022 have advised that as the Jarnail Singh batch of cases are still pending in the Supreme Court of India, any promotion order issued shall be subject to further orders that may be passed by Supreme Court in the said batch of cases. Further, Railway Board vide their letter dated 21.12.2023 (RBE No.147/2023) have advised that reserved category candidates can compete for non-reserved post and in the event of their appointment to said post, their number cannot be added or taken into consideration for working out the percentage of reservation".
