**OFFICE ORDER NO. RWF/ESTT/13 DATED 10.01.2024**

Disciplinary proceedings for imposition of major penalty was initiated against Shri R Arumugam (Staff No.079492), ACMT/Axle/RWF, under the Railway Servants (D&A) Rules, 1968, vide Major Penalty Charge Memorandum No.RWF/DAR/CVC/RA/01 dated 05.03.2020, on the charges of corrupt practices and demanding bribe from the calcined lime supplier to RWF.

After going through the Charge Memorandum dated 05.03.2020, IO's report dated 09.07.2022, and representation dated 28.12.2022 submitted by the said Shri R Arumugam thereagainst, and other records relevant to the case, the Railway Board being the Disciplinary Authority, have decided to impose the penalty of 'Removal from service which shall not be disqualification for future employment under the Government or Railway Administration' on the said Shri R Arumugam ACMT/Axle/RWF, vide Railway Board's order No. E(O)I-2020/PU-2/RWF/63 dated 02.01.2024. The penalty advise has been served on the above officer through his controlling officer on 10.01.2024.

Accordingly, Shri R Arumugam ACMT/Axle/RWF cease to be in Railway service, from the date of service of penalty advice.
