In view of the above instructions of Railway Board, the above promotions will be subject to outcome of the main SLPs and the Contempt Petition (C)No.314/2016 in SLP (C)No.4831/2012 which are still pending. Further, Railway Board vide their letter dated 22.06.2022, have advised that as the Jarnail Singh batch of cases are still pending in the Supreme Court of India, any promotion order issued shall be subject to further orders that may be passed by Supreme Court in the said batch of cases.
