Rail Wheel Factory intends to engage Allopathic Specialists and Medical Practitioners on contract basis to combat COVID-19 pandemic and for the Covid Critical Care Centre (ICU).

**1 Eligibility Criteria/Qualification:**

**i) Specialist in Critical Care Medicine (Intensivists):-**

The candidate should be a MBBS Graduate and possess Post Graduation Degree in Emergency Medicine/Anesthesia with 3 years of experience.

**OR**

The candidate should be a MBBS Graduate and possess Post Graduate Diploma in Emergency Medicine /Anesthesia with 5 years experience for managing ICU patients in CCU.

**ii) Contract Medical Practitioner:-**

The candidate should be MBBS Graduate and should be in possession of a valid registration certificate of any of the State Medical Council of India after completion of one year compulsory rotatory internship. Candidates who possess Post Graduate Degree/Diploma in any clinical subjects are preferred.

**5. Terms and conditions:-**

- (a) The period of contract of doctors engaged would be on full time basis for the period indicated at para 3 above. Further the services of these Doctors are also terminable before expiry of the contract by either side after giving fifteen days notice or on payment of fifteen days remuneration in lieu of the same. The services rendered as contract doctors is a stop gap arrangement and will not have any bearing in respect of consideration of their period of service in case of regular selection through UPSC. It will also not confer any right for regularization or absorption.
- (b) All the candidates proposed to be engaged should have good physical and mental health as per Railway Medical standards and they will be subjected to medical examination and should be found fit.
- (c) The candidates will have to bring the following original documents along with one self-attested copy of the documents:
  - i. Date of birth certificate or SSLC/SSE Board Certificate
  - ii. All Education certificates (eg. SSLC/SSC, HSC, MBBS Degree and Degree certificates of any higher Medical/ Educational Qualification etc)
  - iii. If working, NOC from the current employer
  - iv. Experience certificate, if any.
  - v. Academic/Educational Qualification must be from a recognized Institution/ Board (Mark Sheet and Certificate)
- (d) In case of unsatisfactory work or misconduct on part of the personnel so engaged on contract basis, Railway reserves the right to terminate the contract at any time without assigning any reasons thereof.
- (e) In case, any discrepancy is noticed regarding fulfillment of eligibility conditions at any time, the candidature will be rejected without assigning any reason.
- (f) Appearance in the interview will not vest any right upon the candidates to be engaged and no reason will be cited or communication shall be made with the candidate in the event of the candidates not getting selected.
- (g) No private practice or any other employment will be permitted during the contract period.
- (h) The Administration reserves the right to deploy the doctors depending upon the requirement of the service and refusal or otherwise will be deemed as misconduct on the part of the candidates.

- (i) The selected candidate will be paid remuneration as noted in Para-2 mentioned above and the candidates cannot claim any additional remuneration, allowances or other benefits during the course of contract period.
- (j) The candidates are personally responsible for payment of professional tax, income tax and other duties/ taxes leviable by the State/Central Governments from time to time.
- (k) The Railway Administration reserves the right to cancel, amend or otherwise modify all or any of the terms of the notification without assigning any reason thereof.
- (l) The eligible and willing candidates should report to the venue on the date/time of interview along with the filled up application form in the prescribed format appended, duly enclosing necessary self attested copies of testimonials and producing original certificates for verification. Only eligible candidates who fulfill the prescribed conditions will be eligible for Walk-in-Interview. Application received with incomplete documents will summarily be rejected.
- (m) No TA/DA will be paid to the candidates for attending the interview and they have to bear their own expenses to attend the interview.
- (n) The candidates are advised to be prepared to stay for more than one day at Bangalore, if required, for the above interview.
- (o) All the candidates are advised to follow Covid Appropriate Behaviour.
- (p) The contract doctors shall not be entitled to Railway Quarters, etc., as a matter of right. However, if available they will be provided accommodation.
- (q) The detailed instructions with regard to their duties while on contract with Railways shall be given to them in the event of their selection alongwith the offer of engagement.

6. Retired Railway doctors upto the age of 65 years may also apply, on fixed remuneration of Rs. 75,000/- per month (subject to the condition that remuneration plus pension drawn by retired Railway doctor will not exceed the last pay drawn). The details of scheme, terms and conditions as notified in terms of Rly Board's letter No.2008/E(GR)II/1/1 dated 16.07.2012, will be applicable for engagement of retired Railway doctors as Contract Medical Practitioners (CMPs).
