Sanction of the Competent Authority is hereby communicated for Inter Railway mutual transfer of Shri. Saran Madamana (Staff No. 086609) SSE/D&D working in Level-7 of RS(RP) Rules, 2016 of Mechanical dept. of this Factory with Shri. Vijay P. (PF No. 42829800048) SSE in Level 7 of RS(RP) Rules 2016, P&R/Central Workshop/CWS/MYSS, South Western Railway, subject to the following terms and conditions:-

1. They will be assigned seniority in the new unit to which they are transferred as per extant orders applicable to such mutual transfer (i.e, they will retain their own seniority or take the seniority of the other whichever is lower).
2. They should not normally seek re-transfer to their parent unit at a later date.
3. They are not eligible for joining time, TA, DA, Transfer Pass and Composite Transfer Grant etc., as the transfer is ordered at their own request.
4. They should vacate the Railway Quarters before being relieved. They should hand over all the Railway materials, if any under their possession to the authority concerned.
5. Their lien will be maintained in the parent Railway till such time they are permanently absorbed in the new Railway Unit.
6. The Employees should be free from DAR/SPE/Vigilance cases as on date of their relief.
7. The above mutual transfer shall be complied with the Instructions contained in Railway Board's letter No.E(NG)I-2018/TR/8 dated 11.01.2019 (RBE No.8/2019).
