1. She will rank junior to all permanent, temporary and officiating Helpers on the date of her joining as Helper in Level-1 of RS (RP) Rules 2016 in the new unit.
2. She should not seek retransfer to the parent unit at a later date.
3. She is not eligible for joining time, TA,DA, Transfer Pass and Composite transfer grant as the transfer is ordered at her own request.
4. She should vacate Railway Quarters if any in occupation before being relieved. She should hand over all the Railway materials, if any under her possession to the authority concerned.
5. Her lien will be maintained in RWF/YNK till such time she is permanently absorbed in the new Railway/Unit.
6. Her Inter-Railway request transfer is approved, in terms of instructions contained in Railway Board's letter No. E(O)III/2014/PL/05 dated 04.01.2016.
7. The employee is free from DAR/SPE/Vigilance cases on the date of her relief.
8. Smt. Soni Kumari shall abide by all the formalities as per the guidelines issued by Ministry of Home Affairs for prescribed Institutional/Home quarantine and also follow Covid-19 procedure applicable for Inter-state/Intra-state travellers prevailing at the time of reporting in the new unit on transfer, including quarantine if any.
