2. He should not seek retransfer to the parent unit at a later date.
3. He is not eligible for joining time, TA,DA, Transfer Pass and Composite transfer grant as the transfer is ordered at his own request.
4. He should vacate Railway Quarters if any in occupation before being relieved. He should hand over all the Railway materials if any under his possession to the authority concerned.
5. His lien will be maintained in RWF/YNK till such time he is permanently absorbed in the new Railway/Unit.
6. The employee is free from DAR/SPE/Vigilance cases on the date of his relief.
7. Shri. G K Srinivas shall abide by all the formalities as per the guidelines issued by Ministry of Home Affairs for prescribed Institutional/Home quarantine and also follow Covid-19 procedure applicable for Inter-state/Intra-state travellers prevailing at the time of reporting in the new unit on transfer, including quarantine if any.
