
OFFICE ORDER No. RWF/ESTT/198 DATED 01.08.2022

Railway Board vide their letter No. 2016-E(SCT)I/25/8 dated 30.09.2016 (RBE No.117/2016) & 2018-E(SCT)I/259 dated 28.12.2018 have advised that instructions contained in RBE No.126/2010 dated 01.09.2010, should be held in abeyance with immediate effect until further advice and all further promotions of reserved category persons to unreserved posts will now be made by ignoring Railway Board's RBE No.126/2010 dated 01.09.2010. In view of the above instructions of Railway Board, the above promotion will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP (C) No.4831/2012 which are still pending.
