



Terms and conditions to be uploaded on RWF website

1. The procurement value for last financial year was Rs.15,00,000 (Rupees Fifteen Lakhs only).The annual turnover for the vender should be at least 30% of our annual purchase (C . A ' certificate for last 03 (Three) years to be submitted along with the EOI)
2. Contract period shall be valid for a period of 02 (Two) years from the date of issue of Letter of Acceptance
3. Medicines are to be supplied along with appropriate bills and vender should deliver the medicines on the same day as ordered without fail. In emergency,the medicines may have to be supplied immediately.
4. The payment of the bill will be done once in 15 (Fifteen) days.
5. The technical eligibility will be based on criteria like proper cold storage and qualified manpower.
6. The service should be at least for 12 hours per day and retail out let must be within 7 (Seven) kilometers from RH/RWF.
7. The Railway Hospital / Rail Wheel Factory has rights to include / delete the registration without any intimation at any time, this is based on the performance of successful supplier as assessed by the undersigned.
8. As for as possible the same brand of the drug ordered to be supplied by the vender.
9. Authorized representative of the vender shall sign in the performance register regularly.
10. Documents to be submitted;
 - a) Valid Drug License
 - b) GST Certificate
 - c) Address Proof
 - d) Last 3 years CA certificate for certificate for 30% of the average turnover to be submitted
 - e) Performance certificate from other institutions supplied by the vendor, if any.
