Sub: Formation of panel for the post of Technician Gr.III/Mechanic (Motor Vehicle) in Level- 2 of RS(RP) Rules'2016 in the Mechanical dept.

It is proposed to form a panel to fill up the existing and anticipated vacancies of Technician Gr.III/Mechanic (Motor Vehicle) in Level- 2 of RS(RP) Rules'2016 from amongst eligible Helpers of Mechanical & Electrical department who fulfill the following requirements for the working on the shop floor.

Break-up of vacancies : UR- 04 (Four), SC- 01 (One), ST- Nil : Total= 05 (Five)

The volunteering staff should fulfill the following conditions:-

They should have rendered a minimum regular service of 02 years in RWF.
They should have passed a minimum of 08th Standard.
Must possess current Heavy and Light Vehicle driving License.
Must have attended First-aid course and possess certificate to this effect.

The eligible volunteers will be subjected to a selection, which comprises of a Trade test to check their ability to drive industrial light/heavy vehicles like forklift, truck etc and day-to-day work related to its maintenance.

Usual relaxation is permissible to SC/ST candidates in qualifying standards to the extent of vacancies reserved for them.

The selected candidates will be subjected for medical examination for their physical fit-ness in Bee-One medical category at the time of their posting.


Helpers of Mechanical and Electrical department who satisfy the above requirement may submit their applications in the prescribed proforma enclosed on or before **05.08.2020**, through their controlling officer/s.

The controlling officer/s are requested to forward all the application/s of all the volunteering staff in one bunch so as to reach Personnel department on or before **05.08.2020**. Applications received after the due date or which do not otherwise fulfill the requirements will not be entertained under any circumstances.

This may please be given wide publicity from amongst all the eligible staff and arrangements may also please be made to notify the staff who are on long leave, placed on sick list, proceeded on duty, training, etc. on the above subject. The responsibility of notifying the candidates rests with the Controlling Officers/Supervisors.

This may please be treated as alert notice and volunteering staff should be ready to appear for the Trade test at a short notice.
