Shri. Harish S Itagi, S/o Late Satish V Itagi, who has been selected on Compassionate Grounds for appointment by General Manager as **JE(IT)** against an existing vacancy at MIS Centre/RWF and having accepted all terms and conditions stipulated in this office offer of appointment letter No. RWF/ACS/ADMN/HSI/IE(IT) dated 12/04/2019 is declared medically fit by ACMS/RH/RWF/YNK, Bangalore- 560064 vide fitness Certificate No.21858 dated 09/04/2019. His Date of birth is 16/06/1994 and has taken the Oath of Allegiance to the constitution of India. He has accepted the offer of appointment as Temporary JE(IT) in Level Six (6) with basic pay Rs.35400/- (Pre Revised pay band Rs.9300-34800/- Grand pay of Rs.4200/-) w.e.f **17/04/2019(F/N)** against an existing vacancy and is posted to MIS Centre. In addition to pay, he is eligible for usual Allowance as admissible to him.

His appointment is purely on temporary basis, as per conditions laid down in para 2 and 3 of this office offer of appointment letter No.RWF/ACS/ADMN/HSI/IE(IT) dated 12/04/2019 and his services are terminable without notice or assigning any reasons thereof. It must be clearly understood that the appointment is terminable on 14 days notice on either side except that no such notice is required if the termination of service is due to the expiry of sanction to the posts he holds. Also no such notice will be required if the termination of service is due to his mental or physical incapacity or to his removal or dismissal as a disciplinary measure after compliance with provision of clause 2 of the articles 311 of the Constitution of India.

His appointment to the post of JE(IT) is subject to the following conditions:

1. He should undergo all Training/Refresher Courses as required by this Administration from time to time.
2. If at any later stage, the Certificates submitted by him in support of his Educational Qualifications and other eligible conditions are found to be not genuine, he is liable to be removed from service without any notice.
3. He will not be eligible for any benefits, under the State Railway Provident Fund as well as under the Railway Services (Pension) Rules 1993. His appointment is subject to the provisions of the New Pension Scheme effective from 01/01/2004 introduced in terms of Railway Board's letter no.(E)/III/2003/PNI/24 dated 31/12/2003.

4. In all matters not specifically provided for herein or in the Recruitment Rules, he will be governed by the provision of Indian Railway Codes and other extant Orders as amended/issued from time to time.
