श्री एम. दिनकर, सहायक बिजली इंजीनियर/समूह 'ख' सेवा आर एस आर पी नियम 2016, धातुकर्म विभाग के सी एम टी के वरिष्ठ वेतनमान पद को अस्थायी तौर पर संचालित करते हुए अनारक्षित पद पर वरि. बिजली इंजीनियर के रूप में पदोन्नत किया जाता है और तत्काल प्रभाव से वरि.बि.इंजी./डब्ल्यूएससी प्रणाली के रूप में पदस्थापित किया जाता है । उनका पदोन्नति पूरी तरह तदर्थ आधार पर है और पदोन्नति ग्रेड में वे इस आधार पर किसी भी वरिष्ठता, स्थायी आदि के हकदार नहीं होंगे ।

The Senior Scale post of CMT in Level-11 of RSRP Rules 2016 of Metallurgical Department is temporarily transferred to Electrical Department for its operation as Senior Electrical Engineer/WSC Systems.

Shri. M.Dinakaran, AEE/ Group 'B' service in Level-10 of RSRP Rules 2016 is promoted to officiate in Senior Scale against a UR post and is posted as Senior Electrical Engineer by operating the vacant Senior Scale post of CMT of Metallurgical Department temporarily and is posted as SEE/WSC Systems with immediate effect reporting to CWE/Wheel.


His promotion is ordered purely on adhoc basis and will not confer upon him any prescriptive right for seniority, continuance etc.. in the promoted grade.

The above promotions are subject to the following conditions:-

1. That the out come of writ petition/appeals/application pending in the Supreme Court/HighCourts, CATs as the case may be.
2. Railway Board vide their letter No. 2016-E(SCT)/1/25/8 dated 30.09.2016 (RBE No.117/2016) & 2018-E (SCT)/1/25/9 dated 28.12.2018 have advised that Railway Board's RBE No.126/2010 dated 01.09.2010, is held in abeyance with immediate effect until further advice, and all further promotions of reserved category persons to unreserved posts will now be made ignoring Railway Board's RBE No.126/2010 dated 01.09.2010. In view of the above instructions of Railway Board, the above promotions, will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP (C) No.4831/2012 which are still pending.


