The following changes are ordered in the Gazetted cadre of Mechanical Department with immediate effect:-

1. Shri. J.L.Desai, AWM, presently working as Assistant Vigilance Officer is promoted to officiate in Senior Scale against a UR post and posted as Works Manager/Service Shops against an existing vacancy vice Shri. N.Easwaran retired on attaining the age of superannation with effect from 31.05.18
2. The Senior scale element of the vacant post of Works Manager/Wheel Shop Maintenance is attached to the JS/Group 'B' post of Assistant Works Manager/ Inspection for operation in Senior scale in Level-11 of RSRP Rules 2016 as WM/Inspection.
3. Shri. H.Lakshmikantha; (SC), AWM/Inspection (and also looking after the duties of APE), is promoted to officiate in Senior scale on adhoc basis and is posted as Works Manager/Inspection in Level-11 of RSRP Rules 2016 against the arrangement indicated in para 2 above against a post reserved for 'SC' and against an existing vacancy.

Their promotions are ordered purely on adhoc basis and will not confer upon them any prescriptive right for seniority, continuance, etc., in the promoted grade.

The above promotions of Group 'B' Officers are also subject to the following conditions:-

That the outcome of the writ petition/appeals/application pending in the Supreme Court/High Courts, CATs as the case may be.

Railway Board vide their letter No. 2016-E(SCT)/1/25/8 dated 30.09.2016 (RBE No.117/2016) have advised that Railway Board's RBE No.126/2010 dated 01.09.2010, is held in abeyance with immediate effect until further advice, and all further promotions of reserved category persons to unreserved posts will now be made by ignoring Railway Board's RBE No.126/2010 dt:01.09.2010. In view of the above instructions of Railway Board, the above promotions, will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP (C) No.4831/2012 which are still pending.
