No. RWF/PM-35/761 Dated 24.05.2019, on completion of the prescribed training and having qualified in the exam conducted at TTC/RWF, is promoted and posted as Junior Engineer/Maintenance in Level- 6 of RS(RP) in the Wheel Shop Maintenance of Mechanical department with immediate effect against an existing vacancy.

The above promotion is provisional and subject to the following conditions:-

1. That the outcome of the writ petition/appeals/application pending in the Supreme Court/High Courts,CATs as the case may be.
2. Railway board vide their letter No.2016-E(SCT)/I/25/8 dated 30.09/2016 (RBE No.117/2016) have advised that Railway Board's RBE No.126/2010 dtd. 01.09.2010, is held in abeyance with immediate effect until further advice, and all further promotions of reserved category persons to unreserved posts will now be made by ignoring Railway Board's RBE No.126/2010 dt. 01.09.2010. In view of the above instructions of Railway Board, the above promotion will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP(C) No.4831/ 2012 which are still pending.
3. That he is free from DAR/SPE/Vig. cases and not undergoing any penalty debarring him from promotion. It is the personal responsibility of the supervisory official concerned to ensure the above, before implementing the promotion order.




