In view of the above instructions of Railway Board, the above promotion/s will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP(C) No.4831/ 2012 which are still pending.
3. That they are free from DAR/SPE/Vig. cases and not undergoing any penalty debarring them from promotion. It is the personal responsibility of the supervisory official concerned to ensure the above, before implementing the promotion order.
