In view of the above instructions of Railway Board, the above promotions will be subject to outcome of the main SLPs and the Contempt Petition (C) No.314/2016 in SLP (C)No.4831/2012 which are still pending.
3. That he is free from DAR/SPE/Vig. cases and not undergoing any penalty debarring him from promotion.
