In view of the above instructions of Railway Board, the above promotions will be subject to outcome of the main SLPs an and the Contempt Petition (C) No.314/2016 in SLP(C) No.4831/ 2012 which are still pending.
3. That he is free from DAR/SPE/Vig. cases and not undergoing any penalty debarring him from promotion. It is the personal responsibility of the supervisory official concerned to ensure the above, before implementing the promotion order.
